*Q. What forms do I need to use?*

**Construction Stormwater General Permit Forms:**

- Summary Overview . . . . . Just summarizes what the permit says.
- Construction Stormwater General NPDES Permit . . . . . This is the general permit itself.
- Definitions and Acronyms . . . . . A reference with the meaning of regulatory phrases.
- Notice of Intent (NOI):  
. . . . . **To apply for coverage** under the construction stormwater general permit.
- Notice of Intent Instructions: . . . . . Self-explanatory.
- Rainfall Erosivity Waiver Application: . . . . . **To apply for a Rainfall Erosivity Waiver.**
- Rainfall Erosivity Waiver Application Instructions: Self-explanatory.
- Construction Rainfall Erosivity Waiver Fact Sheet 3.1:  
. . . . . Use this fact sheet to calculate the RUSLE value for the construction project.
- Contractor's Certification Form: . . . . . Self-explanatory.
- Document Certification Form: . . . . . Use this form to submit additional information.
- Individual Lot Certification:

. . . . . Use this form when selling parcels, lots or an individual lot within a subdivision.

Owners or operators, including, but not limited to, developers, general contractors and builders who have permit coverage under the construction stormwater general permit need to use the Individual Lot Certification (ILC) form when selling parcels, lots or an individual lot. One ILC may be used by one new owner for any number of lots under the same authorization.

- Notice of Termination:  
Use this form to discontinue permit coverage under the construction stormwater general permit.
- Notice of Transfer of Ownership:  
Use this form to transfer permit coverage when an entire property is sold. For the sale of parcels, or lots, or an individual lot within a subdivision, use the ILC form.
- Erosion Control for Home Builders: . . . . . A basic guidance document.
- Fact Sheet: Construction Stormwater General Permit: . . . . . Basis for the general permit.
- Exceptional State Waters, Special Aquatic Life Use Waters; and Outstanding National Resource Waters: . . . . . Use this list of waters when completing section B of the NOI.
- Small Municipalities List (.pdf):  
A list of communities which may be required to implement local Stormwater Pollution Prevention programs under Phase II.
